APPLICATION FOR INSPECTION OF SCREENING EQUIPMENT AND PROCEDURES USED TO ALLOW THE SHIPPING OF CORN, BROOMCORN, SORGHUM OR SUDAN GRASS TO THE FOLLOWING STATES: ARIZONA, CALIFORNIA, IDAHO, NEVADA, OREGON, TEXAS, UTAH AND WASHINGTON.

Complete the application portion of this form and return both copies to the South Dakota Department of Agriculture, along with the **\$200.00 annual inspection fee.**

All grains of corn and sorghum (milo) will be passed through a scalper screen of ½” mesh or less. All screens will be checked regularly when in use. No screen will be used that is loose in the frame, is excessively worn, torn, has any condition that would allow the regulated crop debris to become mixed with the cleaned commodity or is otherwise unable to be operated properly.

All screened debris will be handled in such a way that it cannot become mixed with the product to be shipped.

All railroad cars, trucks, and other containers will be thoroughly cleaned of all debris before loading. This will include the floors, ledges, protuberances, recesses, overhead door tracks (inside and outside) and any other area where debris might accumulate.

Certificates issued under this compliance agreement are only applicable to shipments loaded at the facility listed in the Facility Location section on this application. Fumigation or other treatment methods are not approved for self-certification under this agreement.
