**Fire Situation Description:**

Fire was reported approximately 1129 07/24/2012. Active control actions were immediately taken by all represented agencies. Control actions have been initiated and are ongoing on all fires as appropriate.

**Decisions (list here):**

It is hereby agreed that the cost basis on this incident (Falls Incident, SD-BKF-120792) will be shared as follows:

All costs excluding aviation will be shared by the Black Hills National Forest and the South Dakota Division Wildland Fire (based on containment acres) for the period (1) 1129 07/24/2012 to 2400 07/28/2012.

This agreement will be modified to include containment acres. All costs will be shared between Black Hills National Forest and the South Dakota Division Wildland Fire based on containment acres, at the December 2012 cost settlement meeting.

Each agency will pay their own costs and set up a time and place in December 2012 for a meeting at which time each agency will bring their actual costs. At that time, an actual total cost of the fire will be determined and used to determine each agency's actual payment cost. Any costs incurred after this time (DEC 2012) will be the responsibility of agency/county that receives the bill.

Tort Claims for damages are outside the scope of the cost share agreement.

Rehabilitation costs with the exception of those fireline activities that are part of the suppression activities will be the responsibility of the jurisdictional agency.




